- ✓ The Admit Card is issued provisionally to the candidates, subject to the fulfilment of the eligibility conditions.
- ✓ Issue of Admit Card, however, will not necessarily mean acceptance of eligibility which shall be further scrutinized at subsequent stages of the recruitment process.
- ✓ Admit Card will **NOT** be sent by post.
- ✓ Candidate must not mutilate the Admit Card or Change any entry made thereon, while carrying a copy of the same to the Exam Centre.
